Competitive tenders duly super- scribing the name of works, are invited (By Speed Post/Registered Post Only) by the undersigned in the prescribed form, for the work mentioned below. The bidders should have a valid PWD Civil work License of "C" Class & above Registration for the civil work Sl.No.1 and valid License of 'C' class and above registration issued by PWD/Kerala State Electricity Licensing Board/Electrical Inspectorate for the Electrical work (Sl.No.2). Tender forms will be issued (against payment of tender cost in cash) up to 1 PM on the last date prescribed for receipt of tender, on production of the valid registration certificate. The tender forms can also be downloaded from the website: www.livestock.kerala.gov.in. In such cases, the cost of tender form should be remitted online (NEFT) to the bank account of KLD Board, the details of which are given below. The UTR message from the bank should be submitted along with the tender as proof of remittance. Copy of the valid registration certificate should also be enclosed along with the tender in such cases. Tenders received through means other than Speed post/Registered post, will not be accepted.
