NOTICE INVITING e-TENDERS FOR CIVIL AND ELECTRICAL WORKS

e-tenders are invited in a single bid system for civil/electrical works from the contractors/contracting agencies having valid Registration/Licence as follows. Only GST registered bidders are eligible to participate in the tender.

FOR CIVIL WORK

Valid "B" Class (or above) Registration/Licence, issued by the Kerala PWD/CPWD/Kerala Irrigation Department, for the works as mentioned under serial no.1 and Valid "C" Class (or above) Registration/Licence, issued by the Kerala PWD/CPWD/ Kerala Irrigation Department, for the works as mentioned under serial nos. 2 to 6. The Registration/Licence should be valid as on the date of opening of the e-tender.

FOR ELECTRICAL WORK

Valid "B" Class (or above) Registration/Licence, issued by Kerala PWD/Kerala State Electricity Licensing Board/Electrical Inspectorate, for the work as mentioned under serial no.7. The Registration/Licence should be valid as on the date of opening of the e-tender.

The Contractors/Contracting agencies should have successfully completed at least one civil/electrical works costing more than 40% of the estimated Probable Amount of the Contract (PAC) of the work tendered (and being quoted), during the previous 5 years, in a Government Department/Public Sector Undertaking/Co-operative Institution.

The tenders have to be submitted as e-tenders, through <https://etenders.kerala.gov.in>. Only those bidders who have enrolled in the above portal with their own Digital Signature Certificate (DSC) can participate in the tender. The tender document and other details can be obtained/downloaded from the above portal.

TENDER SUBMISSION PROCEDURE

The tender is on a single bid system

The scanned copies of the following documents have to be submitted along with the bid online, failing which the bid will be rejected without any notice.

1. Valid "B" Class (or above) Registration/Licence, issued by the Kerala PWD/CPWD/Kerala Irrigation Department, for the works as mentioned under serial no.1, Valid "C" Class (or above) Registration/Licence, issued by the Kerala PWD/CPWD/ Kerala Irrigation Department, for the works as mentioned under serial nos. 2 to 6. and Valid "B" Class (or above) Registration/Licence, issued by the Kerala PWD/Kerala State Electricity Licensing Board/Electrical Inspectorate (for electrical work) as mentioned under serial no.7. The Registration/Licence should be valid as on the date of opening of the e-tender.
2. GST Registration Certificate.
3. Preliminary Agreement, [as per format provided separately along with the tender documents] duly executed in a Kerala Stamp Paper worth Rs. 200/-. Stamp Paper charges are to be borne by the bidder himself and to be signed on all pages. Name of the work being quoted should be clearly mentioned in the agreement.
4. Digitally Signed Tender Document in full (all pages).
5. Declaration in/ as per the form provided, duly filled up and signed by the Bidder, clearly mentioning the tender number and date. Bidders may also use their letter heads for submitting the declaration form (as per the format provided). **If the contractor is found at any stage, to have suppressed any information required, his earnest money for the work is liable to be forfeited and the contract entered into will stand cancelled.**
6. Experience/Completion Certificate for having successfully completed at least one civil/electrical work costing more than 40% of the Probable Amount of Contract (PAC) of the work now tendered (and being quoted by the bidder) during the past 5 years, obtained from any Government Department/ Public Sector Undertaking/Co-operative Institution.
7. EMD exemption certificate (if any).

(Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document, on www.etenders.kerala.gov.in. No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.)
