NOTICE INVITING e-TENDERS FOR CIVIL WORKS

e-tenders are invited in a single bid system for civil works as noted below from the contractors/contracting agencies having valid Registration/Licence (PWD/CPWD) as follows. Only GST registered bidders are eligible to participate in the tender.

Valid "C" Class (or above) Registration/Licence, issued by the Kerala PWD/CPWD/ Kerala Irrigation Department, for the works as mentioned under serial nos. 1 to 5 and Valid "D" Class (or above) Registration/Licence, issued by the Kerala PWD/CPWD/ Kerala Irrigation Department, for the works as mentioned under serial nos. 6 & 7. The Registration/Licence should be valid as on the date of opening of the e-tender.

The Contractors/Contracting agencies should have successfully completed at least one civil work costing more than 40% of the estimated Probable Amount of the Contract (PAC) of the work tendered (and being quoted), during the previous 5 years, in a Government Department/Public Sector Undertaking/Co-operative Institution.

The tenders have to be submitted as e-tenders, through <https://etenders.kerala.gov.in>. Only those bidders who have enrolled in the above portal with their own Digital Signature Certificate (DSC) can participate in the tender. The tender document and other details can be obtained/downloaded from the above portal.

TENDER SUBMISSION PROCEDURE

The tender is on a single bid system

The scanned copies of the following documents have to be submitted along with the bid online, failing which the bid will be rejected without any notice.

1. Valid "C" Class (or above) Registration/Licence, issued by the Kerala PWD/CPWD/ Kerala Irrigation Department, for the works as mentioned under serial nos. 1 to 5 and Valid "D" Class (or above) Registration/Licence, issued by the Kerala PWD/CPWD/ Kerala Irrigation Department, for the works as mentioned under serial nos. 6 &7. The Registration/Licence should be valid as on the date of opening of the e-tender GST Registration Certificate.
2. Preliminary Agreement, [as per format provided separately along with the tender documents] duly executed in a Kerala Stamp Paper worth Rs. 200/-. Stamp Paper charges are to be borne by the bidder himself and to be signed on all pages. Name of the work being quoted should be clearly mentioned in the agreement.
3. The Tender Document in full should be uploaded in token of acceptance of all tender conditions.
4. Declaration in/ as per the form provided, duly filled up and signed by the Bidder, clearly mentioning the tender number and date. Bidders may also use their letter heads for submitting the declaration form (as per the format provided). **If the contractor is found at any stage, to have suppressed any information required, his earnest money for the work is liable to be forfeited and the contract entered into will stand cancelled.**
5. Experience / Completion Certificate for having successfully completed at least one civil work costing more than 40% of the Probable Amount of Contract (PAC) of the work now tendered (and being quoted by the bidder) during the past 5 years, obtained from any Government Department/ Public Sector Undertaking/ Co-operative Institution.
7. Waiving of Bid Security and tender cost is allowed in respect of bidders, who are exempted by Government to that effect. In such cases, the bidder shall produce copy of Government order allowing exemption from remittance of bid security and tender cost while participating in the tender process. If the exemption certificate produced is not a valid one, the tender submitted will be rejected outright.

(Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document, on www.etenders.kerala.gov.in. No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.)
