NOTICE INVITING e-TENDER FOR CIVIL WORKS

e-tender is invited in a single bid system for civil works as noted below from the contractors/contracting agencies having valid Registration/Licence (PWD/CPWD) as follows. Only GST registered bidders are eligible to participate in the tender.

Valid "D" Class (or above) Registration/Licence, issued by the Kerala PWD/CPWD/Kerala Irrigation Department, for the works as mentioned under serial no.1 to 4 [Tender No. CE/12/2026, CE/13/2026, CE/14/2026, CE/15/2026,]. The Registration/Licence should be valid as on the date of opening of the e-tender.

The Contractors/Contracting Agencies should have successfully completed **at least two civil works** costing more than 40% of the estimated Probable Amount of the Contract (PAC) of the work now tendered during the previous 5 years, in a Government Department/Public Sector Undertaking/Co-operative Institution/Universities.

The tenders have to be submitted as e-tenders, through <https://etenders.kerala.gov.in>. Only those bidders who have enrolled in the above portal with their own Digital Signature Certificate (DSC) can participate in the tender. The tender document and other details can be obtained/downloaded from the above portal.

The tender is on a single bid system

The scanned copies of the following documents have to be submitted along with the bid online, failing which the bid will be rejected without any notice.

1. Valid "D" Class (or above) Registration/Licence, issued by the Kerala PWD/CPWD/Kerala Irrigation Department, for the works as mentioned under serial no.1 to 4 [Tender No. CE/12/2026, CE/13/2026, CE/14/2026, CE/15/2026,]. The Registration/Licence should be valid as on the date of opening of the e-tender
2. GST Registration Certificate.
3. **Contractor should submit Experience/Completion Certificate clearly mentioning the estimate PAC, commencement and completion date or by submitting Appendix 1900D for having successfully completed at least two civil work costing more than 40% of the Probable Amount of Contract (PAC) of the work now tendered during the past 5 years, obtained from any Government Department/ Public Sector Undertaking/ Co-operative Institution/ Universities with seal and sign of the concerned officials.**
4. Digitally Signed Full Tender Form.
5. Declaration in duly filled up (as per the format provided) and signed by the Bidder, clearly mentioning the tender number and date. Bidders may also use their letter heads for submitting the declaration form. If the contractor is found at any stage, to have suppressed any information required, his earnest money for the work is liable to be forfeited and the contract entered into will stand cancelled.
6. Preliminary Agreement, [as per format provided separately along with the tender documents] duly executed in a Kerala Stamp Paper worth Rs.200/- or above. Stamp Paper charges are to be borne by the bidder himself and to be signed on all pages. Name of the work being quoted should be clearly mentioned in the agreement. e-stamp Paper is also allowed for executing the Preliminary Agreement.
7. EMD exemption not allowed.

(Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document, on www.etenders.kerala.gov.in. No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.)

Hard copies of the following two documents should reach to the office of the Managing Director, KLD Board Ltd., "Gokulam" Pattom P.O, Thiruvananthapuram - 695 004 on or before 14.10.2026, 5.00 pm failing which the bid shall be rejected.
